# Important Information and Booking Conditions

BOOKING FORM A booking form must be completed and signed on behalf of all passengers travelling to confirm the reservations. Please read conditions.

DEPOSIT The completed booking form together with a non-refundable deposit of \$600.00 per person must be sent to O'Connor Travel World to secure your place on the pilgrimage. Payment may be made by direct deposit to our bank account, bank or personal cheque.

FINAL PAYMENT Balance is due no later than 60 DAYS PRIOR TO DEPARTURE or AS STATED ON YOUR INVOICE. Payment may be made by direct deposit to our bank account, bank or personal cheque. No credit cards accepted as payment for pilgrimages.

## CANCELLATION CHARGES Fees are per person.

- From payment of deposit
- till 60 days prior to departure ...... loss of deposit paid
- 60-45 days prior to departure ...... 50% of payment
- 45 days till date of departure ...... 100% of payment
- post departure ...... 100% of payment

ADDITIONAL TRAVEL BOOKINGS An administration fee of \$50 per person will be made for extra travel to your group booking including air, accommodation, rail, car hire, ferries, tours etc. Amendments incur a cost of \$25 per change.

TRAVEL INSURANCE We strongly suggest you obtain travel insurance to cover any unforeseen circumstances prior to and whilst travelling.

DOCUMENTATION Australian/NZ citizens require a passport which must be valid for at least 6 months from their date of departure. With regard to visas, you will be advised as to what is required when the booking is made.

PILGRIMAGE PRICE All prices are guoted in Australian dollars. These costs may change due to currency fluctuations and at the discretion of the airlines and/or operators.

PILGRIMAGE CANCELLATION All are costed on 20 full paying passengers departing Australia and/or NZ. Should number of passengers fall below this number the pilgrimage may have to be recosted or cancelled.

PRICE DOES NOT INCLUDE charges for passport, visas, meals not specified in itinerary, drinks, laundry, excess baggage, items of a personal nature, travel insurance, tips, vaccinations/innoculations, etc.

DISABILITIES Any physical, mental or emotional disability MUST BE REPORTED IN WRITING when a booking is made.

DISCLOSURE OF PRIOR ARRESTS, CHARGES AND CONVICTIONS In the event that you are travelling to a country or countries which do not require a visa for Australian passport holders, you must tell us if you have been arrested or convicted in respect of any offence or breach of law. Non disclosure of this information may lead to your being refused entry on arrival in certain countries. In that event, we take no responsibility whatsoever.

If you do not wish to disclose such information to us, then you must contact the embassy of each country of destination and make your own arrangements in regard to entry to that country.

- 1. DEFINITIONS For the purposes of these conditions, the following words shall have the meanings set below them:
- "The Business."
- O'Connor Travel World and/or its associated companies or agents. "The Contractors"
- The person or corporation providing the transportation, accommodation or other services.
- "The Passenger"
- The person or persons embarking on the Tour.

"The Tour"

The tour or tours or travel arrangements specified on the flyer.

- The Business is acting as a booking agent only for the Contractors in relation to 2. the Tour. Insofar as the Business shall not be acting as booking agent, it shall be deemed to be acting as the Passenger's agent.
- 3. All receipts, tickets, vouchers, coupons or exchange orders are issued subject to the terms and conditions endorsed thereon or upon other documentation supplied by the Contractors and under which the Contractors provide the relevant transportation, accommodation or other services as part of the Tour.
- 4. The Business shall not be liable for any injury, damage, loss, accident, delay, or irregularity that may be caused to persons or property however caused or arising during or in connection with the Tour and any other services booked through the Business. The Business makes no representation or warranty with respect to the standard of transportation, accommodation, or other service to be provided by the Contractors and shall not be liable or in any way responsible for any failure by the Contractors to provide such services. In addition, the Business believes that contents of the flyer promoting the Tour to have been true at the time of printing, but makes no express or implied agreement, representations or warranty to that effect or in relation to any of the contents of that flyer.
- 5. Subject to Condition 6, the Business reserves the right to cancel the Tour at any time prior to the departure date in which case any deposit or other payments made on account, the Tour shall be refunded to the Passenger in full, and subject to the refund of those monies, the Passenger shall have no right to claim damages from the Business and/or the Contractors.
- 6. The Business shall be entitled to cancel the Tour at any time either prior to or during the Tour by reason of the occurrence of a fire, flood, earthquake, storm or tempest, riots, civil unrest, military coup or change of government or any other act or event occurring in the country or countries on the itinerary of the Tour and which the Business may in its reasonable discretion decide constitutes a danger to the security and well being of the Passenger, and in the event of such cancellation the Business shall not be responsible for the refund of any deposit or other payments made by the passenger on account of the Tour, and the Passenger shall have no right to claim damages from the Business.
- 7. All fares and rates for transportation, accommodation or any other services associated with the Tour are subject to change by the Business and/or the Contractors without notice to the Passenger, the Business reserves the right to require further payment to cover any increases in fares and rates for the Tour and also any change in exchange notes for foreign currencies occurring prior to the departure of the Tour.
- The Business reserves the right to change at any time at its discretion and 8. without notice to the Passenger, the itinerary, accommodation or travel arrangements for the Tour and the Passenger acknowledges that such changes may also be made or directed to be made by the Contractors.
- 9. The Business and the Contractors reserve the right either before or during the Tour to refuse to carry or accommodate any Passenger which it considers to be unsuitable by reason of physical or mental condition.
- 10. The Passenger consents to all monies paid to the Business in the form of a deposit or otherwise being used for any purpose associated with reservations and bookings for the Tour, which may include payment to a Contractor or its booking agent by way of confirmation, instalments or deposits and the like and may not be recoverable from the Business and/or the Contractor in the event that the Passenger alters or cancels the booking.
- 11. After departure, if for any reason whatsoever the Passenger does not utilise any travel arrangements, accommodation or meals, no refund or other allowance will be made in respect of any lost or unused tickets, passes, vouchers or coupons, PROVIDED THAT should the Business be able to obtain any refund in respect of any such lost or unused tickets, passes, vouchers or coupons, it shall hold these monies in credit and will forward such monies, less that reasonable costs and expenses of the Business in obtaining that refund, to the Passenger as soon as is reasonably practicable.
- 12. Where the Passenger has made a booking on behalf of persons other than himself, the Passenger confirms that he is acting with the full knowledge and consent of such other persons and that he has the full authorisation for such persons to bind them to these Conditions.
- 13. These conditions shall be binding upon the Passenger as well as his heirs, executors, administrators and legal personal representatives and also upon any family member or minor or other person on whose behalf the Passenger executes this Agreement and their respective heirs, executors, administrators and legal personal representatives.
